RESOLUTION AUTHORIZING A ONE-YEAR EXTENSION OF EXISTING CONTRACT WITH MAIN POOL AND CHEMICAL COMPANY, INC. IN AN AMOUNT NOT TO EXCEED \$56,200.00


WHEREAS, on March 23, 2009 the Township Council of the Township of Livingston authorized the Township Manager to enter into a twelve month contract with Main Pool and Chemical Company, Inc. for the purchase of water treatment chemicals for items 1, 2, 3, 8, 9, 10 & 11; and


WHEREAS, pursuant to 40A: 11-15, the Township will extend its existing contract for an additional one-year with Main Pool and Chemical Company, Inc. for items 1, 2, 3, 8, 9, 10 & 11 at the same prices bid; and


WHEREAS, the Township Manager is recommending a one-year extension of the contract with Main Pool and Chemical Company, Inc. for items 1, 2, 3, 8, 9, 10 & 11 at the same prices bid in an amount not to exceed \$56,200.00; and

WHEREAS, funding will be available in the 2010 and 2011 budgets, under accounts 0-26-55-501-000-284 (Chemicals), 0-05-55-502-001-221 (Supplies), 0-07-55-502-002-221 (WPCF-Supplies), 1-26-55-501-000-284 (Chemicals), 1-05-55-502-001-221 (Supplies) and 1-07-55-502-002-221 (WPCF-Supplies) subject to the appropriation of sufficient funds in the 2010 and 2011 municipal budgets.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Livingston, in the County of Essex, State of New Jersey, that it authorizes the Township Manager to extend the contract with Main Pool and Chemical Company, Inc. for items 1, 2, 3, 8, 9, 10 & 11 for one-year in an amount not to exceed \$56,200.00.


