

**RESOLUTION AUTHORIZING A CONTRACT WITH ARNOLD FURNITURE MANUFACTURERS, INC.
UNDER NEW JERSEY STATE CONTRACT NUMBER A70354 IN AN AMOUNT NOT TO EXCEED
\$21,000.00 FOR OFFICE FURNITURE FOR THE NEW MUNICIPAL COMPLEX**

WHEREAS, the Township of Livingston ("Township") has a need to purchase office furniture systems for the new Municipal Complex; and

WHEREAS, the firm of Arnold Furniture Manufacturers, Inc. was identified as the lowest responsive and responsible bidder under New Jersey State Contract Number A70354 whose bid meets all of the requirements of the bid specifications, complies with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.S.A. 17:27 et seq., is responsive and responsible, and is the most advantageous to the Township; and


WHEREAS, the Township Manager, Township Engineer and Purchasing Manager have evaluated the proposal for qualifications, experience, and cost reasonableness, and recommend the award of a contract to Arnold Furniture Manufacturers, Inc.; and




