

RESOLUTION AUTHORIZING A CONTRACT WITH BUSINESS FURNITURE INC. UNDER NEW JERSEY STATE CONTRACT NUMBER A69935 IN AN AMOUNT NOT TO EXCEED \$264,000.00 FOR OFFICE FURNITURE FOR THE NEW MUNICIPAL COMPLEX

WHEREAS, the Township of Livingston ("Township") has a need to purchase office furniture systems for the new Municipal Complex; and

WHEREAS, the firm of Business Furniture, Inc. was identified as the lowest responsive and responsible bidder under New Jersey State Contract Number A69935 whose bid meets all of the requirements of the bid specifications, complies with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.S.A. 17:27 et seq., is responsive and responsible, and is the most advantageous to the Township; and

WHEREAS, the Township Manager, Township Engineer and Purchasing Manager have evaluated the proposal for qualifications, experience, and cost reasonableness, and recommend the award of a contract to Business Furniture, Inc.; and


WHEREAS, the Township Manager is recommending the award of a contract to Business Furniture, Inc. in an amount not to exceed \$264,000.00 for office furniture; and

WHEREAS, the Chief Financial Officer has certified that funding is available in the 2010 capital budget, under account C-04-55-010-006-010 (Improvements to Municipal Property).

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Livingston, in the County of Essex, State of New Jersey, that it authorizes the Township Manager to enter into a contract with Business Furniture, Inc. under New Jersey State Contract Number A69935 in an amount not to exceed \$264,000.00.




