RESOLUTION AUTHORIZING APPROVAL OF THE FINAL CHANGE ORDER WITH STANZIALE CONSTRUCTION LLC FOR THE MILLING AND REPAVING OF PUTNAM ROAD

WHEREAS, the Township Council of the Township of Livingston entered into a contract (“Contract”) with Stanziale Construction LLC for the Milling and Repaving of Putnam Road; and

WHEREAS, the initial Contract was not to exceed One Hundred Ninety Seven Thousand, Seven Hundred and Seventy Six Dollars and Thirteen Cents; and

WHEREAS, due to field conditions resulting in supplemental work items, extra items and reduced quantities, a Change Order has been requested for the following:
