

**RESOLUTION AUTHORIZING APPROVAL OF THE FINAL CHANGE ORDER WITH STANZIALE CONSTRUCTION LLC
IN THE AMOUNT OF \$17,070.98 FOR THE MILLING AND REPAVING OF PROSPECT AND SUNSET ROADS**

WHEREAS, the Township Council of the Township of Livingston entered into a contract (“Contract”) with Stanziale Construction LLC for the Milling and Repaving of Prospect and Sunset Roads; and

WHEREAS, the initial Contract was not to exceed One Hundred Fifty Eight Thousand, Five Hundred and Seventy Eight Dollars and Fifty Six Cents; and

WHEREAS, due to field conditions of additional requested work resulting in an addition to final quantities, a Change Order has been requested for the following:
