FINDINGS AND CONCLUSIONS

The Zoning Board of Adjustment of the Township of Livingston, having considered the Application and plans filed in this matter, and the testimony and evidence presented at the hearing on October 24, 2017, the following findings of fact and conclusions are made:

1. The Applicant is: Luis and Susie Fernandes.
2. The Property is commonly known as 12 Orchard Lane, and is taxed as Block 2101, Lot 15. The property is in the R-3 Zone.
3. The Applicant has satisfied the statutory procedural requirements of service and publication of notice, and there are no taxes or assessments due or in arrears.
4. The Applicant proposes to install an in-ground pool. Violation of the following Livingston Zoning Ordinance was noted:
 - (a) Section 170-96-A(8)F - Swimming Pool Setback - 20 feet required, 11 feet proposed; a 9-foot variance requested;
5. The following persons testified at the hearings: The Applicants. The Board heard testimony, and considered the plans submitted in conjunction with the Application.
6. The following persons objected to, or expressed interest in, the application at the hearings: None.
7. The Board found that the Applicant satisfied the statutory requirements of N.J.S.A. 40:55D-70(c)(1) for the relief sought by demonstrating that the Applicant has a hardship due to a shallow lot, and the location of the house on the lot. The Board found that the lot can accommodate the proposed swimming pool. The Board found that by granting the variances there will be no substantial detriment resulting to the public good, nor will there be an impairment of the zoning plan or municipal zoning ordinance.
8. Now, therefore, be it **RESOLVED** by the ZONING BOARD OF ADJUSTMENT of the Township of Livingston that the application herein submitted is granted the following variances from the Ordinance:

- (a) A Swimming Pool Setback variance of 9 feet is granted.

This approval is subject to all other requirements of the Township ordinances, building code, and the right of appeal by any interested party. Also, as required by Livingston Ordinance 170-27(A), construction must be commenced within one year of the date hereof or the variance shall expire.

Copies of the Applicant's survey showing the proposed improvements and architectural plans are attached hereto as an exhibit to indicate the final version thereof.

This Resolution is a memorialization of the action of the Board of Adjustment of the Township of Livingston taken on June 27, 2017 in which Board voted six in favor and none opposed to approve the application.


