**FINDINGS AND CONCLUSIONS**

The Zoning Board of Adjustment of the Township of Livingston, having considered the Application and plans filed in this matter, and the testimony and evidence presented at the hearing on March 25, 2014, the following findings of fact and conclusions are made:

1. The applicant is Patrick Cao.
2. The property is commonly known as 12 Emerson Drive and is taxed as Block 1103, Lot 34. The property is in the R-4 Zone.
3. The applicant has satisfied the statutory procedural requirements of service and publication of notice, and there are no taxes or assessments due or in arrears.
4. The applicant proposes to construct an addition to a single-family residence.
5. Violations of Livingston Zoning Ordinances:
  - (a) Section 170-99C(2) Front Yard Setback – 40’ required, 36.2’ proposed; 3.8’ variance requested;
  - (b) Section 170-99C(3) Side Yard Setback – 10’ required, 8.9’ proposed; 1.1’ variance requested;
  - (c) Section 170-99C(3) Side Yard Aggregate Setback – 26.1’ required, 25.19’ proposed; .91’ variance requested; and
  - (d) Section 170-99C(4) Rear Yard Setback - 35’ required, 28.6’ proposed; 6.4’ variance requested.
6. The following persons testified at the hearing: The applicant and Margaret Pedersen, AIA.
7. The following persons objected to or expressed interest the application at the hearing: none.
8. The applicant has satisfied the statutory requirements of N.J.S.A. 49:55D-70 (c)(1) for the relief sought by demonstrating that there is a hardship due to the shallowness and unusual shaped of the lot.

Based upon the above findings, there will be no detriment resulting to the public good, nor will there be an impairment of the zoning plan or municipal zoning ordinance. Now, therefore, be it **RESOLVED** by the ZONING BOARD OF ADJUSTMENT of the Township of Livingston that the application herein submitted is granted the following variances from the Ordinance:

Front Yard Setback Variance of three and eight tenths feet (3.8');  
Side Yard Setback Variance of one and one tenth feet (1.1');  
Aggregate Side Yard Setback Variance of ninety one one hundredths feet (0.91');  
and  
Rear Yard Setback variance of six and four tenths feet (6.4') are granted.

The applicant agreed to remove the shed to a location in compliance with the Ordinance and no final Certificate of Occupancy shall be issued until that is completed.

This approval is subject to all other requirements of the Township ordinances, building code, and the right of appeal by any interested party. Also, as required by Livingston Ordinance 170-27(A), construction must be commenced within one year of the date hereof or the variance shall expire.

Copies of the Applicant's survey showing the proposed improvements and architectural plans are attached hereto as an exhibit to indicate the final version thereof.

The Resolution is a memorialization of the action of the Board of Adjustment of the Township of Livingston taken on March 25, 2014 in which Board voted to six in favor and none opposed to approve the application in accordance with and subject to the conditions and terms set forth herein on the record.
